... Jeannie! Jeannie joined the Eastern Landlord Association in 2006 and was happy to take part in our first interview.

Can you give us a brief overview of how you came to be a landlord and why?

"We fell lucky with being able to purchase a house and a flat before the banks realized they could use the second income and property prices went silly.

We then mortgaged the flat to pay for the house which we live in.

The house then became available to borrow on to put the deposit on two other rental properties.

The rentals were meant to be our pension. Unfortunately, because of a volatile financial climate and constant persecution from the government it is not going to happen as planned and it is now too late to change plans".

What do you feel makes a good landlord?

"Being accommodating to your tenants but not letting them take advantage of you.

Mending and fixing things immediately when needed and not being greedy."

What has been your biggest mistake?

"Trusting agents!"

How do you find good tenants?

"You don't. You sometimes get lucky and get a good one. All you can do is do your best by them and hope that the respect is reciprocated".

What would you say to your "younger" landlord self?

"Don't get hung up on the smaller details, concentrate on the bigger picture.

Talk less, listen more and hear what's being said".

A Thought from a Director...

Another year has passed and what a year it had been for landlords. Firstly, the most recent budget with various tax implications will affect us all but more concerning and looming in the wings is the forthcoming Renters' Rights Bill. Its first reading in Parliament was on 11th September, followed by second reading on 9th October and committee stage 22nd October. Report stage and third reading will take place on 14th January 2025 before the Bill goes to House of Lords to start process all over again. So, whatever you have read so far may be subject to change and alteration.

What we do know for sure is that Section 21 will be abolished.

What this means is a rapid learning exercise for those of us who manage their own properties in order to be fully aware of the Acts contents and implications. This is where ELA membership becomes vital. To be a lone landlord without any such support could be fraught with danger. We are here to provide you with all the knowledge and advice you will need to successfully run and manage your properties. Whether you have just one or many properties this support is vital and also comforting to know that we are only a telephone call/email away. The website has now been revamped and is very informative for members with regular blog updates on

pertinent matters.

There are several scare stories out there regarding landlords selling up and leaving the sector. Whether this is true or not the facts are that there is already a shortage of rental property nationwide meaning the market is actually thriving with far more tenants than properties. Arguably, this may be a time to increase your portfolio in order to take advantage of this situation which is unlikely to change. There is no doubt that the level of bureaucracy over the years has increased considerably but providing you look upon property letting as a business and approach it from this angle and maintain a level of professionalism you will continue to flourish in today's market.

Despite the national doom and gloom, I take the view that now is the time to grow your business and hopefully take advantage of stagnant house prices.

Next year will no doubt bring its own challenges for landlords, we seem to have a government that is not particularly enamoured with us but so long as there is a housing crisis we will continue to play a vital part in accommodating tenants.
